RELEASE & HOLD HARMLESS AGREEMENT

Whereas, the undersigned has been informed:

...THAT HORSES AND PONIES ARE DANGEROUS ANIMALS. ANY HORSE OR PONY MAY KICK, BITE, STEP OR TRAMPLE ON A PERSON, ROLL OR FALL ON THEM, REAR OR BUCK A RIDER OFF AT ANY TIME WITHOUT REASON OR WARNING, NO MATTER HOW FRIENDLY OR SAFE THE ANIMAL MAY APPEAR.

...THAT HORSES HAVE BRAINS AND REASON FOR THEMSELVES; THEREFORE, THEY CANNOT BE COMPLETELY CONTROLLED BY HUMANS.

Whereas, the undersigned acknowledge the inherent risks involved in riding, feeding, grooming, and working around horses, which risks include bodily injury from using, riding, or being in close proximity to horses, among other risks, and further, that both horse and rider or volunteer can be injured in normal use, competition, schooling, or special events.

In consideration, therefore, for the privilege of taking riding lessons, riding, volunteering, and/or working around horses or participating in any function as pony pack, work-bees, or special events sponsored by Horse North Rescue on the premises owned by Debbie Frost or any other approved foster establishment of Horse North Rescue, the undersigned does hereby agree to hold harmless and indemnify Debbie Frost, Horse North Rescue, and all the officers and directors of Horse North Rescue and any approved foster facilities and further release them from any liability or responsibility for accident, damage, injury or illness to the undersigned or to any horse owned by the undersigned or to any family member or spectator accompanying the undersigned while under the direction, instruction, or on the premises of Debbie Frost or an approved foster facilities for Horse North Rescue.
